ASSUMPTION OF RISK AND RELEASE AGREEMENT

NOTE: For the purposes of this Agreement, the term "I" refers to both Parent/Legal Guardian and Student.

The above-named Student ("Student") wishes to participate in the 2022 Hawaii Construction Career Days ("Career Days"), to be held on September 29-30, 2022, at the Aloha Stadium 99-500 Salt Lake Boulevard, Honolulu, Hawaii 96818).

Career Days is possible due to the efforts of several parties including: private business entities and its employees, union organizations and its members, Hawaii Construction Career Days, a nonprofit corporation and its board members, Hawaii State Department of Education, Department of Transportation, and their employees and agents, and the Department of Accounting and General Services, and their employees and agents, (hereafter collectively referred to as "Participating Entities").

Every effort will be made to ensure a safe learning environment for all participants.

In order for Student to participate in Career Days, Student and Student's Parent/Legal Guardian acknowledge and agree to the following:

- Student will be allowed to participate in several hands-on construction activities. These activities include, but are not limited to: participating in construction equipment static displays and hands-on activities with selected construction equipment. A trained operator will be present with all equipment used for providing students with hands-on experiences.
- Some of the activities will take place on an unpaved, open area of Aloha Stadium. The surface of this area is covered with loose gravel.
- Student shall read any and all written materials setting forth the requirements for participation and safety procedures and guidelines. Such requirements include guidelines for appropriate attire (long pants, covered shoes). **Shorts, tank tops, sandals, slippers (flip-flops), open toe shoes will not be permitted under any circumstances.** Student shall strictly observe and comply with all guidelines; safety procedures and instructions included in these written materials, as well as those explained by instructors or Career Days staff. Failure to observe guidelines, safety procedures or instructions may result in Student's removal from the Career Days activities.
- There are inherent dangers and risks involved in the Career Days activities which may result in illness, property damage, personal injury or death. These risks include, but are not limited to: crush injuries, cuts, lacerations, bruises, injuries from flying debris, inhalation of dust or debris from cutting or sanding projects, or falling from equipment.
- There are inherent risks from the open area location of the activities. These include, but are not limited to: possible exposure to heat and strong sun, possible exposure to windy or rainy weather, walking across rough surfaces and loose gravel and the possibility of tripping and falling on such surfaces.

In consideration of Student being permitted to participate in Career Days, I voluntarily assume full responsibility for any loss, property damage or personal injury, including death that may be sustained as a result of Student's participation. Further, for myself (both Student and Parent/Legal Guardian), our heirs, personal representatives or assigns, I hereby release, waive, and discharge the Participating Entities, their officers, employees, agents, assignees and members from any and all claims or actions for property damage, personal injury and/or death arising from Student's participation in Career Days or growing out of or caused by any acts or omissions of the Student during participation in Career Days.

I have read this Assumption of Risk and Release Agreement and I understand that I am giving up substantial rights, including the right to sue. I acknowledge that I am signing this Agreement freely and voluntarily.

I agree that if any portion of this Agreement is held invalid, the remainder will continue in full force and effect.

RELEASE FOR USE OF IMAGE, NAME

I understand that the 2022 Hawaii Construction Career Days will attract media coverage. There is a possibility that students will be photographed during the experience. I grant permission to photograph my son or daughter named above for promotional and educational purposes.
